**ORDER AUTHORIZING THE DISTRIBUTION OF THE  
WEISHENG/CPG DIRECT PURCHASER SETTLEMENT FUND**

WHEREAS, the Direct Purchaser Damages Class entered into a settlement agreement with Defendants Weisheng Pharmaceutical Company, Ltd. (“Weisheng”) and China Pharmaceutical Group, Ltd (“CPG”);

WHEREAS, the Court preliminarily approved the settlement, and directed Class Counsel to issue notice of the proposed settlement to potential class members;

WHEREAS, publication and mailing notice were issued;

WHEREAS, following a fairness hearing, the Court granted final approval to the settlements, approved the plan of allocation, and awarded attorneys’ fees and expenses;

WHEREAS, Class Counsel also recommended that \$43,712.36 be paid at this time from the Direct Purchaser Settlement Fund to Rust Consulting, Inc. (“Rust Consulting”) for work

related to claims administration, and that an additional \$12,587 be withheld from distribution to cover Rust Consulting's additional fees and expenses incurred in completing the distribution process;

WHEREAS, the Net Settlement Fund to be distributed to class members is calculated after deduction of the Court-approved attorneys' fees and expenses, administrative expenses, taxes and tax expenses relating to the income earned by the settlement fund, and any other necessary adjustments under the Court's orders or the settlement agreement;

WHEREAS, Rust Consulting, as the Court-approved Claims Administrator, has evaluated and audited claims forms from potential claimants, and calculated the appropriate amount to be allocated to each qualified claimant;

WHEREAS, the funds owed to Great Earth Chemical from this distribution are currently subject to a dispute between North American World Trade Group and QualChem LLC, which this Court has referred to Magistrate Judge Orenstein;

**THEREFORE, IT IS HEREBY ORDERED, ADJUDGED AND DECREED:**

Direct Purchaser Plaintiffs are authorized to pay claims administration costs of \$43,712.36 to Rust Consulting from the Weisheng Direct Purchaser Settlement Fund, and to withhold an additional \$12,587 for Rust Consulting's anticipated future fees and expenses related to the distribution process; and

The Net Settlement Fund shall be distributed to class members who have submitted valid claims, as determined by Rust Consulting, and in the amounts that Rust Consulting recommends, as set forth in Exhibit B to the Declaration of Charlene Young, dated April 4, 2014, with the

exception that the amount owed to Great Earth Chemical, LLC from this distribution will be held in escrow pending resolution of the dispute between North American World Trade Group and QualChem LLC.
